# **Port Strategy Leadership Project**

The Port Safety Leadership Group was reformed and is represented by, PIA, Port CE's, WorkSafe, Maritime NZ, RMTU and MUNZ. They are committed to working in a tripartite way, planning and delivering vision on projects.

The project team firstly agreed on the top critical risks, for both Ports and Harbours, the three agreed critical risks were person vs machine, falling from heights and suspended loads.

The timeline is to gather insights and data and have it ready by midyear for evaluation. For each risk look at what the key themes are and what data has been collected to give insights on the risks.

MNZ are proposing to get insights from the regulator, workers, Ports and Stevedores, as they believe these will be very powerful insights to use. Next steps will then be looking at what's behind the causes and working on interventions.

We will continue to provide updates as they are available.

## **Fatigue Management Project update**

This project is also part of the Port Strategy Leadership group.

A lot of work has been completed and we are waiting for a final draft to share with Industry before an implementation plan is rolled out.

The draft will be shared and any further updates.






We will be using the Whova app again this year, download the app and keep up to
