# Troy Evans, Recipient of the 2024 Grant Wilson Memorial Award



Late Port of Tauranga pilot and tug master Troy Evans is the 2024 recipient of the PIA's Grant Wilson Memorial Award, it was announced at conference. This award recognises outstanding contribution to the Port Industry.

Port of Tauranga nominated Troy for the award in recognition of his outstanding contributions to maritime safety and efficiency. Troy took on a leadership role in developing global best practice guidelines for trapdoor set-ups in Pilot Boarding systems, after rigorous practical research and collaboration with maritime experts worldwide. He invested a lot of his own time testing different pilot ladders, trialing different lashing arrangements and systems and testing to destruction. The results of Troy's research and tests were widely shared with industry, making a significant impact on the maritime industry worldwide.

Troy had early onset Parkinson's disease and passed away in December 2021. This the second year the PIA has awarded the Grant Wilson Memorial Award, named in honour of Port of Tauranga's late Container Terminal Operations Manager Grant Wilson's outstanding, lengthy contribution to the Port Industry.

The 2024 trophy was presented to Troy's wife Marilyn Evans and daughters Tessa and Catelyn at the conference dinner.

## Launch of the ACoP for Loading and Unloading Cargo at Ports and on Ships

A joint industry/Regulator launch of this ACoP has just been held at the Port of Auckland to mark it coming into force on November 29th. The Associate Minister for Transport, Hon Matt Doocey spoke via video-link and the Minister for Workplace Relations and Safety, Hon Brooke van Velden, attended alongside Pat Kirk and Jaqui Ramsay for the PIA, CEs from the port and stevedoring sector, and Maritime NZ.

This ACoP was developed collaboratively with the sector and unions, using real scenarios and practices on New Zealand ports to set a clear and consistent baseline, and support the sector to put in place effective controls for safety risks. It had previously been signed by Ministers van Velden and Doocey.

For the first time, all commercial ports in New Zealand now have a code of practice approved by the Minister to follow. The ACOP replaces all other existing industry codes of practice related to stevedoring.

The Port Health and Safety Leadership Group – made up of ports and stevedoring companies, the Port Industry Association, unions and Maritime NZ – is pleased to see one of its key priorities under its multi-year work programme to address inconsistency of practice and reduce harm on New Zealand's ports, come into force.

Leadership Group Chair, Director of Maritime NZ, Kirstie Hewlett, said the ACOP provides assurance and clarity under the Health and Safety at Work Act. If a business can show what they've done is equivalent to or better than the requirements in the ACOP, then they are likely to be meeting the test of what is reasonably practicable under HSWA.

Maritime NZ will take the ACOP into account when undertaking inspections, assessments and investigations and when deciding the appropriate enforcement action.

#### **Port Industry Training Qualification Review**

With our "By Industry for Industry" mantra, we're proud to announce the successful completion of the first stage in reviewing the Level 3 Ports Qualification.

This milestone reflects our commitment to aligning training with the needs of our members and the broader industry.

To ensure the framework meets Industry requirements, we conducted a member survey to identify what's working, what isn't, and how the qualification can be improved.

The feedback emphasized three key areas for improvement:

- Flexibility: Training should accommodate diverse schedules & learning preferences
- Accessibility: Easy access to resources is essential
- **Duration**: The current qualification process is too lengthy

We've taken this feedback onboard and developed a Level 3 qualification framework that offers an ideal entry point for newcomers. Planned future development of Port qualifications beyond level 3 will provide clear pathways for our industry.

We'd like to extend our heartfelt thanks to PIA members and their organizations for their invaluable contributions, attending workshops for this review, alongside Hanga are rau.

Looking ahead, we're excited to collaborate with PCANZ on developing microcredentials and skill standards. These initiatives will provide targeted, flexible training options, ensuring our industry remains innovative and future-ready.



#### **PCANZ** update

The Port and Crane Academy of New Zealand (PCANZ) continues to expand its training opportunities to meet industry needs, offering cost-effective, highquality training designed and delivered by Industry for Industry.

#### Recent highlights include:

**Program Development:** PCANZ is pleased to announce that the Port Operations Level 3 and Cranes Level 3 qualifications, as well as micro-credentials like SafeStart (L3) and Straddle Carrier Operations, are now approved by NZQA and ready for delivery.

**Future Offerings:** Development continues on additional micro-credentials, including Vessel Mooring Skills, Heavy Machine Operations, and Ship Crane Operations, to provide tailored learning opportunities for the sector.

**Support Tools:** Plans for learner health and wellbeing tools and a student information system aim to create a sustainable training ecosystem.

**Funding Update:** PCANZ is actively working with TEC to secure the reallocation of funds from MITO for the delivery of the Level 3 qualification. Support letters have been obtained from MITO, Hanga-Aro-Rau, and the Port and Health & Safety Leadership Group (PHSLG), and we are awaiting TEC's response.

PCANZ is committed to delivering practical, industry-relevant qualifications and invites members to engage with these initiatives. For more details or to collaborate, reach out to PCANZ.

A draft peer review schedule has been proposed for 2025, including all Ports and Stevedoring companies.
